NAVY STEAMS IN TO HELP JAMES BOND

BOND is back – and for the Royal Navy it could be the biggest Bond yet.
Final preparations are being made before filming can begin on the new 007 blockbuster, currently known simply as 'Bond 18'.
Details have yet to be finalised, but according to the Royal Navy's company, Productions, the Royal Navy would feature prominently as an integral part of the plot.
"Major Bond is a man of action whose Bond goes to the heart of the matter," says the company. "Most of the film will be set in a hot and humid climate, and the Royal Navy will be seen in a variety of roles, from the operations of the fleet to the operations of the Royal Navy's ships."
